

### **DELIVERING FOR THE DISTRICT**

An important part of the annual budget process is when members of Congress advocate for federal funding to support community projects run by nonprofits and state or local governments. I successfully brought home **\$14.36 million for 15 community projects throughout the district for Fiscal Year 2024, and am advocating for more support for the 2025 cycle**.

#### Constituent Services Spotlight: Last Minute Passport for Community Service Trip

### Paul McCann reached out to my Congressional Office for assistance obtaining a **last-minute passport**

**to chaperone a group of local high school students on a community service trip** to Costa Rica through Social Voyagers, a nonprofit based in Redwood City. One of the parent chaperones fell ill and Paul was asked to step in the day before their flight.

My casework team scheduled an appointment at the San Francisco Passport Office immediately and he received his passport the next morning. The students were able to make their trip to Samara, Costa Rica where they painted a community building as an act of service. The students also attended a local school to interact with and learn from the people of Samara.

Paul will be making good use of his passport once again as he plans to lead a new group of 23 students to Japan in June 2025.

#### Constituent Services Spotlight: Cancer Patient Gets Help Navigating Medicare

Undergoing cancer treatment is stressful enough, so when an East Palo Alto resident turned 65 years old and ran into an issue with Medicare, he contacted my Congressional Office for help.

To pay for the cancer treatment drugs, he needed to use a copay assistance program through his spouse's health insurance. To qualify for the copay assistance program, he couldn't be on Medicare. When he turned 65 years old, he was automatically enrolled in Medicare and ran into an issue trying to waive coverage.

As a constituent, **the resident was assigned a caseworker from my office who helped him work with the federal agency** to stop the prescription coverage he'd been trying to waive and receive a refund on the premiums.

A caseworker from my office was able to reach out to coordinate with Medicare to waive his coverage and qualify for the copay assistance program, which helped him pay for his cancer treatment.



"I was being treated for cancer and time was of the essence. I hadn't been able to fix my situation with Medicare directly, so I decided to reach out for help. I am very thankful that Congressman Mullin and his district staff were able to quickly help resolve my issue," said the East Palo Alto resident.

# **LEGISLATIVE UPDATES**

#### **Clean Energy & Environment**

Climate change is one of the biggest challenges of our lifetime. My constituents and communities around the country are experiencing its impacts right now. I understand the gravity and immediacy of ensuring a livable future for our children. That's why I believe we must confront the climate crisis head-on to protect our communities and the environment.

Expanding clean energy in America is vital to our economy and the environment. This year, the Federal Aviation Administration Reauthorization Act of 2024 was passed to authorize the agency for another 5 years. This new law includes **provisions I authored that will help advance clean energy in aviation and reduce the industry's carbon footprint**.

My amendments will support research and development of hydrogen aviation fuel and better prepare America's power grid for the future of electric power in aviation.









# **LEGISLATIVE UPDATES**

#### **Emergency Preparedness**

We need to be prepared as we face an increasing number of climate-driven disasters, which is why I've been working on a bipartisan basis to **increase funding for the Urban Search & Rescue (US&R) System Task Forces.** This came after we led a bipartisan group of lawmakers from across the country to fight for this funding in the FY25 Appropriations process

There are 28 US&R task forces in 19 states – one of which deploys out of our own community in Menlo Park and East Palo Alto.

US&R task forces respond to disasters wherever they strike, yet they have been underfunded for years. While this funding increase is not yet law, I am hopeful that we can see it across the finish line this year.

#### **Flood Protection**

Our communities are all too familiar with the impacts from extreme storms and flooding. That's why I fought for changes in this year's Water Resources Development Act to help **study flood risks and stormwater management in our district.** 

This will help the City of San Mateo's flood risk management efforts and increase the per-project spending limits for the Army Corps' flood mitigation programs. The House and Senate approved versions of the bill, and I expect them to become law soon.

# **BILLS INTRODUCED**

### **Poverty Line Act**



The current Federal Poverty Line – just \$31,200 for a family of four in 2024 – does not accurately reflect what it takes for households to meet their basic needs and have an opportunity to achieve social and economic mobility.

The Poverty Line Act would update the way the poverty line is calculated so it reflects today's cost of living and is adjusted for regional differences across the country. This is critical to helping millions of hard-working families who earn too little to make ends meet, but for whom safety net programs have been out of reach.

#### **Earthquake Resilience Act**

Nearly 75 percent of the U.S. could experience a damaging earthquake in the next century. But many communities across America are not prepared to deal with this threat, and earthquakes cost the U.S. on average \$14.7 billion annually.

To address these gaps, the Earthquake Resilience Act would require a national risk assessment of earthquake resilience and support the development of standards and guidelines to more quickly restore access to critical lifeline infrastructure following a disaster. ### Driver Technology & Pedestrian Safety Act

### Congressman explores tech's role in safety

San Mateo Daily Journal October 29, 2024 Pedestrian injuries and fatalities from traffic accidents are at record highs. In 2022, more than **7,500 pedestrians were killed and more than 67,000 pedestrians were injured.** 

This bill would direct the Department of Transportation to conduct a study on the effects of driver technology – including touch screen-based systems and user interface design – and the impact of time of day and changes in traffic, weather, and the volume of commercial vehicles on the road as they relate to pedestrian injuries and fatalities.

#### Weatherization Resilience and Adaptation Program (WRAP) Act

Extreme weather and natural disasters driven by climate change are having the most devastating impact on those who can least afford to guard against them. Severe storms, routine flooding, extreme heat, and massive wildfires have become more common, putting Americans, especially low-income communities in low-lying and coastal regions, increasingly at risk of losing their homes and property.

The WRAP Act would **provide financial assistance to low-income homeowners and affordable housing providers to make changes to their property so they are more resilient to climate-driven natural disasters** and better adapted to withstand dramatic shifts in weather patterns.
